Jackie Kaiser from Associated Environmental Consultants Inc. virtually attended the council meeting on October 8, 2025, from 7:01 PM to 7:10 PM.

Jackie confirmed that the D&R Plan is ready for submission. During the submission process, Associated Environmental Consultants Inc. will request that the Ministry allow the Ogema Landfill site to remain operational for an additional 15 to 20 years. The Ministry might reduce this timeframe to 5-7 years.

Regarding the CHIF grant application, the submission deadline is November 28, 2025. This timeline does not provide sufficient time for the Town to prepare an application. Therefore, we plan to apply during the next intake in 2027. This grant could potentially be utilized for progressive closure initiatives. The Town Council's directive is to keep the landfill active for as long as feasible.
