Mayor Peterson extended a warm welcome to Jonah Toth from SUMAInvest, who joined us at 7:01 PM. Jonah provided valuable insights into the operations of SUMAInvest and highlighted the benefits it offers to the Municipality.

SUMAInvest, a partnership between the Saskatchewan Urban Municipalities Association and the Saskatchewan Community Foundation, is a program aimed at strengthening municipal financial capacity through pooled reserve investment. It uses the Saskatchewan Community Foundation's diversified and professionally managed investment portfolio to help municipalities grow reserves. Third-party investment managers apply strategic insights to maximize returns and reduce risk. The well-balanced investment portfolio includes alternative investments in infrastructure, real estate, and mortgages, reducing exposure to market volatility. Municipalities can withdraw funds at any time without penalty, and the funds remain under ownership and accounted for on financials. The low fees charged by the Community Foundation support local jobs and communities, with a portion dedicated to local impact investing. The program is open to all Saskatchewan communities with a minimum initial investment of \$10,000. The SUMAInvest portfolio balances market-based equities with alternative investments, offering greater potential for investment growth and reduced risk.
